## Strategic Partnership (SP)

The Partnership last met on 19 September 2012. Click [here](#) to view the agenda and minutes.

Vic Allison, Wychavon's Deputy Managing Director, told us about the **Council Tax changes consultation**. The national Council Tax Benefit scheme provides financial help to people with low or no incomes to pay their Council Tax bills. The Government is abolishing the national scheme and asking all councils to replace it with a scheme of their own, to be called Council Tax Support.

The Government is also making some changes to the Council Tax Regulations, giving local councils the chance to make changes to the rules about which properties are exempt from Council Tax and which qualify for a discount. Wychavon is also proposing some changes to these rules. Wychavon is consulting on its proposals and changes. To take part in the consultation and read the proposals click [here](#). The consultation closes on **Friday 26 October 2012**. The scheme will be introduced from 1 April 2013.

Vic also updated us on **car parking issues** that were discussed at our last meeting. Wychavon will be reviewing long stay car parking and will consider reducing the all

day maximum charge and the cost of season tickets.

We were given an update **on Localism**. [The Localism Act 2011](#) received Royal Assent on 15 November 2011. The Act contains a series of measures aimed at shifting power away from central government back into the hands of individuals, communities and councils. Wychavon District Council has set up a [Localism and Communities Advisory Panel](#) to advise on implementing various elements of the Act, including the new community rights to bid, build and challenge. The panel, which is chaired by Cllr Audrey Steel, comprises eight district councillors and three community representatives. Its responsibilities also include:

- Assessing [Wychavon Community Grant](#) applications.
- Considering [New Homes Bonus](#) proposals.
- Overseeing the [Connecting with communities programme](#)
- Reviewing [Local Strategic Partnerships'](#) action plans.
- Developing stronger relationships across all tiers of local government.

A **Local Communities event** for parish and town councils and community groups is being held on **24 October** from **6.00-8.30pm** at the Civic Centre, Pershore. It will include talks on: setting up a community car share club, improving Broadband speeds, bulk energy switching schemes, community land trusts and Neighbourhood Planning. Two door knocks have recently taken place in Harvington, Norton and Badsey with over 150 referrals coming from it. A six week healthy cooking course is underway. The boiler project and handyperson project has started. The OVoE Skills Officer has
