Another option for here and elsewhere in the village would be if anyone has any unwanted small trees in their gardens or on their land that we could transplant. Karl requested that the village be made aware of the request".

To: All member councils

Dear All,

You may have seen the paragraph in last week's Update about the County Council's withdrawal of grant funding from CALC. We knew that the £25,000 per year reward grant funding from the County Partnership had ended, as that was awarded for a fixed period of four years. In addition, the County Council has given us £7,000 per year for a number of years, and that has gone as a result of the County's internal restructuring and the need for it to make budget savings.

County officers are looking for ways to continue to support CALC, and Cllr Sue Baxter, CALC Executive Committee chairman, and I, are due to meet Clare Marchant, the new County Council Chief Executive, on September 8<sup>th</sup>.

At its meeting last Wednesday, the CALC Executive Committee thought that it would be very helpful if member councils wrote to Ms Marchant to express their support for the Association and also if they raised the issue with their county councillors. The Committee thought that it was very likely that County Council members would not be aware of it.

The Committee's views were that

- The amount of the saving was a tiny proportion of the County Council's spending, even considering the total amount of the grant paid in the last four years.
- The County Council has obtained very good value from the spending on the grant to the Association
- The County Council wishes to continue to improve close links with parish and town councils to further its localism agenda
- It derives benefit itself from the support that parish and town councils obtain from membership of CALC and NALC when it works with those councils to further mutual aims
- Continued support now will help the Association to achieve long term financial stability. Its withdrawal will prejudice the likelihood of survival

Your support in writing to Ms Marchant and in canvassing the support of county councillors would be very greatly appreciated.

## CALC Funding IN CALC UPDATE DATED 10 JULY

Over the last few years, CALC has relied heavily on grant funding from the County Council and the County Partnership, which has now ceased. About half of the Association's income has come from this source. The Executive Committee has tried, and failed, over an extended period, to find other sources of income to replace the grants, knowing that they would not continue in the long term.

The Committee has reluctantly concluded that if CALC is to continue in existence, the majority of its funding must come from subscriptions.

At yesterday's meeting, it agreed the proposals of the Funding Working Group, which were that it should:

(1) Resolve to bring us back in to balance within 5 years, not allowing the reserves to drop below £25k in any budget.

(2) Adopt the subscription escalator at an initial rate of 11% per annum for 5 years, the rate to be reviewed each year.

(3) Pursue the identified (and others if they arise) opportunities with vigour, reducing the escalator if actual opportunities materialise (as part of the annual review of the escalator).

(4) Continue with the current subscription formula (cap at 1,306 electors) which means a rise of 11% per annum (subject to review) in the CALC elector rate. The Association has healthy reserves because of the grant funding, and they will be used to allow the programme of subscription increases to be spread over a period of years. The strategy will be reviewed regularly to ensure that it remains appropriate. Costs will continue to be kept as low as possible while maintaining service to members.

Our Chairman, Sue Baxter, and I are due to meet the new County Council Chief Executive on September 8th, to explore the possibility of alternative support.

### **Appendix 3: Birlingham Cricket Club**

I am writing on behalf of Birlingham Cricket Club Committee to see if the Parish Council were able to provide any support in respect of improvement works the club has planned during this year. As you are aware the Cricket Ground is the main recreational area within the village and its facilities support many village events enjoyed by parishioners. In recent years we have hosted the Village Sports day, the Jubilee celebrations, the Fete and of course the biennial Classic Car Rally and occasional music nights.

Like most small clubs in the area we have to fund raise in order to maintain the facilities on the ground. Currently the club is looking to raise approximately £1500 for the replacement of the machine shed roof and repairs to the club house window frames and possible replacement of the club house doors. This is all essential improvement and upkeep which benefits the community on the occasions when Cricket Ground is used for village events.

We do hope the Parish Council would be in a position to offer financial support, however small, and look forward to hearing from you.

### **Appendix 4: Badsey Open Meeting**

On the 6<sup>th</sup> of June I attended, on behalf of the Birlingham Parish Council, a meeting held by the Badsey P C to express its anger and frustration at the effects of the government's planning rules.

The key facts were:

Between 2001 and 2011, the number of dwellings in the village had increased by 19%

From 2011 to 2014 the number of additional dwellings approved had increased by 25%

July 2014

From 2014 to 2016 if all the proposed additional dwellings are approved the number of additional dwellings will be 36%

**Overall from 2001 to 2016 the number of dwellings will have increased by 70% and it is estimated the population of the village will have increased from 2425 to 4873, an increase of 81%**

It was explained that no members of the Wychavon planning staff or local councillors would attend as the meeting was outside the legal process and their presence might be prejudicial to future planning decisions.

Sir Peter Luff, the local M.P. (retiring at the next election) defended the government's position.

The Badsey council complained that:

Planners and district councillors seemed powerless to prevent each and every planning application being approved despite the wishes of the community  
The village plan, completed after much consultation and confirming the community's opposition to massive expansion, carried no status in the planning decisions and it had been advised to replace it with a Neighbourhood Plan

Sir Peter Luff referred to the national need for more houses and declared that until the South Worcestershire Local Plan was approved nothing could be done to stem the flood of applications. He said the government could not interfere with established legal processes and in effect blamed Wychavon for not having a 5 year supply of housing sites. When it was pointed out that the new Local Plan would not be fully operational until 2015, his advice was to be patient. He mentioned that Whittington faced a possible expansion of 340%.

I think it is fair to say that, despite the M.P.'s sympathetic and considerate handling of questions, the meeting was deeply unconvinced by his argument; it was felt that the present situation had been brought about by a cynical and covert manipulation of the planning process in the government's wider aims and that it was a complete denial of the flaunted "localism". The Conservative Party may have some problems getting support in that and many other Vale villages
